Aims and Content

The socio-economic research seminar pursues two objectives: First, members of the Institute as well as students of the MA Socioeconomics should have the opportunity to participate in current research debate in socioeconomics within the framework of a lecture series, as well as to actively engage with research work at an advanced stage. This will not only enable participants to broaden their theoretical and methodological knowledge, but will also give them the opportunity to explore new areas of research. The research seminar generally takes place every two weeks.

Organization

The lecture series within the socio-economic research seminar is open to students of the MA Socioeconomics and the interested (university) public. Each session contains a German- or English-language lecture on current or recently completed research. The lectures are typically 45-60 minutes in length; the remaining time is available for discussion. Slides and accompanying materials for each topic will be made available on Moodle (https://moodle.uni-due.de/course/view.php?id=36674) after each session.

Dates and Topics

The lecture series generally takes place every other week on Thursdays from 16:00-17:30, although individual dates may vary. The following dates are scheduled for the current semester (see table on next page).
